ALL MBD FORMS IN THE BIDDING DOCUMENT MUST BE FULLY COMPLETED AND SIGNED, A COPY OF COIDA CERTIFICATES, CERTIFIED ID COPY OF DIRECTORS.

NB: FAILURE TO SUBMIT ANY OF THE REQUIRED DOCUMENTS WILL RESULT IN THE BIDDING PROPOSAL BEING DISQUALIFIED. BIDDERS WHO DO NOT SUBMIT THEIR VALID B-BBEE STATUS LEVEL CERTIFICATES SHALL NOT QUALIFY FOR PREFERENCE POINTS FOR B-BBEE CONTRIBUTION BUT SHALL NOT BE DISQUALIFIED FROM THE BIDDING PROCESS. ALL RETURNABLE DOCUMENTS SHOULD BE PACKAGED PROPERLY SHOWING INDEXES AND TENDER DOCUMENT SHOULD NOT BE TEMPERED WITH.
