Bidders must attach the following **compulsory** documents: **A valid original Tax Clearance Certificate, a certified copy of Company Registration, Company Profile with traceable relevant experience, a valid Municipal Services Account Statement of the company and owners not in arrears for more than three(3) months, Proposed team CV's with Qualifications, Company registration with professional bodies, certified ID copies of members, Joint Venture Agreement and Power of Attorney in case of Joint Ventures, and Proof of payment for purchase of tender document, and other documents as required in the tender document.** All MBD forms in the document must be dully completed and signed. **NB: Failure to submit any of the required documents will result in the tender proposal being disqualified.**

Tenders fully completed shall be sealed in an envelope marked with both the **"Tender Number and Tender Description"** of the above mentioned projects and be **deposited** in the **tender box** at the Bushbuckridge Local Municipality, Head Office in Bushbuckridge R533 Graskop Road, opposite Mapulaneng DTLC, or **posted** to the address mentioned above, not later than **12H00**, on the **closing date**. Bidders must also submit an **original or certified copy of a B-BBEE certificate** to claim preference points. However, a bidder shall not be disqualified for not submitting a certificate substantiating the B-BBEE status level of contribution nor is a non-compliant contributor.
