ALL MBD FORMS IN THE BIDDING DOCUMENT MUST BE FULLY COMPLETED AND SIGNED, A COPY OF COIDA CERTIFICATES, CERTIFIED ID COPY OF DIRECTORS.

NB: BRIEFING SESSION ATTENDANCE IS COMPULSORY AND FAILURE TO SUBMIT ANY OF THE REQUIRED DOCUMENTS WILL RESULT IN THE BIDDING PROPOSAL BEING DISQUALIFIED. BIDDERS WHO DO NOT SUBMIT THEIR VALID B-BBEE STATUS LEVEL CERTIFICATES SHALL NOT QUALIFY FOR PREFERENCE POINTS FOR B-BBEE CONTRIBUTION BUT SHALL NOT BE DISQUALIFIED FROM THE BIDDING PROCESS. ALL RETURNABLE DOCUMENTS SHOULD BE PACKAGED PROPERLY SHOWING INDEXES, THE TENDER DOCUMENT SHOULD NOT BE TEMPERED WITH.

Fully completed bidding documents shall be **SEALED** in an envelope **CLEARLY MARKED** with both the **“Bid Number and Description”** and be deposited in the Tender Box at the BLM Head Office, R533 Graskop Road, opposite Mapulaneng DLTC, not later than 12H00 on the closing date.
