This is a five years performance contract in terms of section 56 of the Municipal Systems Act No. 32 of 2000. The successful candidate shall report directly to the municipal manager. Suitable candidates should possess the following: **Leadership Competencies** (strategic direction and leadership; people management; program and project management; financial management; change management; and governance); and **Core Competencies** (moral competence; planning and organizing; analysis and innovation; knowledge and information management; communication; and results and quality focus)

REQUIREMENTS: A bachelor's degree in the fields of Accounting, Finance, Economics or Chartered Accountant (SA). Minimum Competency Level certificate as required by National Treasury shall be an added advantage. Candidates without the minimum competency level certificate shall be required to obtain it within 18 months if appointed. Minimum of 7 years' experience at senior and middle management levels; of which at least 2 years must be at senior management level. Must be goal driven, a team player, problem- solver and innovator. A valid driver's license. Need undergo screening, security vetting and competency assessment. Appointed candidate shall sign an employment contract, a performance agreement and disclosure financial interest.

KNOWLEDGE: Good knowledge and understanding of relevant procedures policy and legislation in local government; institutional governance systems and performance management; public office environment; and ability to formulate engineering master planning, project management, implementation and evaluation.
