**BIDS MUST INCLUDE THE FOLLOWING COMPULSORY DOCUMENTS:** (a) Valid tax clearance certificate or SARS pin, (b) Proof of registration with CSD, (c) Company registration, Company profile, (d) Copy of B-BBEE Certificate SANAS accredited or Sworn Affidavit, (e) Municipal rates & taxes of Company and Directors (not older than 3 months in arrears) within the area of jurisdiction, (f) Dully completed and signed MBD forms in the bidding document, and (g) ID copy(ies) of director(s).

**NB:**

- Failure to submit any of the required documents will result in the bidding proposal being disqualified. Bidders who do not submit their valid B-BBEE status level certificates shall not qualify for Preference Points for B-BBEE contribution but shall not be disqualified from the bidding process;
- All returnable documents should be packaged properly showing indexes, the tender document should not be tempered with; and
- People who are in the service of the state should not tender.

**EVALUATION CRITERION**

- Bidders will be prequalified in terms of Regulation 4 of the PPPFA; and
- Bidders who meet the prequalification criteria will be allocated points as part of the functionality.
