Key Performance Areas:

Reporting to the Plant Shift Supervisor, the incumbent will be responsible for the following functions:

- Removal of floating debris from screen disposal of debris to designated areas.
- Assist wastewater treatment operator housekeeping of work area.
- Attend to any duties as assigned by process controllers.
- Maintain records of the quantities of screenings.
- The operator should also note any problems with screening equipment or problems associated with particularly heavy screenings loads.
- Remove or coordinate the safe disposal of screenings from the wastewater works
- Operate mechanical and manual screens at water treatment facilities.
- Lubricate and maintain moving parts of screening equipment.
- Keep logs of daily operations, including debris volume and equipment performance.
- Work closely with plant operators to ensure upstream processes (screening) do not hinder downstream treatment (sedimentation, filtration, chlorination).
